**AGREEMENT TO BE SIGNED BY EVERY DRIVER AND RIDER****A. PROHIBITED SUBSTANCES**

I agree to allow a medical practitioner to examine me prior to or during or following a motor sporting event, meeting or competition. I further agree to allow a sample of my blood and/or urine to be taken for laboratory analysis by the medical practitioner concerned to determine the presence of alcohol or prohibited drugs as listed by the Federation Internationale due Sport Automobile (FISA) and/or Federation Internationale Motorcycliste (FIM) and in accordance with the procedure for testing as prescribed by them. Should the analysis of the sample taken reveal the presence of alcohol or drugs or should I refuse to allow samples of blood and/or urine to be taken, I agree to my suspension for 12 months from participation in all forms of Motor Sport run under the control of MSA, without a Court of Inquiry or Tribunal being conducted by MSA and without my being allowed recourse through Appeal against the 12 month suspension imposed for using alcohol or drugs or for refusing to allow samples of urine or blood to be taken as per this Agreement.

**B. WAIVER AND INDEMNITY**

- The only responsibility of TIR and/or ORGANIZER is to provide a place to race which includes the necessary Emergency Services, I.e. Fire and Ambulance services.
- Prime responsibility for the safe condition and operation of a vehicle in competition rests with the vehicle owner and driver.
- Drivers are required to have a valid driver's licence and MSA Competition Licence and must be capable of the safe operation of the vehicle.
- The main purpose of the Armo barriers is to protect the paying public.
- This ENTRY FORM remains the property of TIR and may not be removed under any circumstances.
- It is the responsibility of the competitor to ensure that all information contained on this entry form is correct.
- I hereby declare myself to be fully acquainted with the nature and extent of the risks involved in participating at TIR, which risks inter alia arise from the high speeds and/or uncontrollability of vehicles using TIR, and further specifically indemnify TIR and/or ORGANIZER against any and all claims arising related to such risks.
