A. PROHIBITED SUBSTANCES

I agree to allow a medical practitioner to examine me prior to or during or following a motor sporting event, meeting or competition. I further agree to allow a sample of my blood and or urine to be taken for laboratory analysis by the medical practitioner concerned to determine the presence of alcohol or prohibited drugs as listed by the Federation International due Sport Automobile (FISA) and/or Federation International Motorcyclist (FIM) and in accordance with the procedure for testing as prescribed by them. Should the analysis of the sample taken reveal the presence of alcohol or drugs or should I refuse to allow samples of blood and/or urine to be taken, I agree to my suspension for 12 months from participation in all forms of Motor Sport run under the control of MSA, without a Court of Inquiry or Tribunal being conducted by MSA and without my being allowed recourse through Appeal against the 12 month suspension imposed for using

B. WAIVER AND INDEMNITY

I, the undersigned, _____ (Full Name) _____ (ID N°) Participating hereinafter referred to as 'the

Participant' in a car of motorbike or race car or dragster for race purposes at Tarlton International Raceway, do hereby declare towards and in favor of the following entities, namely:

1. That I voluntarily participate at Tarlton and at my own risk and own free will.
2. That I hereby waive and abandon any claims of whatsoever nature, rising from the use by me of Tarlton whether resulting from death, bodily injury or otherwise which I may have against Tarlton and Zumick from whatever cause.
3. That I hereby indemnify Tarlton and Zumick against any and all claims, of whatsoever nature, which may be instituted against Tarlton and Zumick arising from the use by me as a Participant while I participate at Tarlton.
4. This waiver and indemnity shall apply to my successors, assigns, dependants and heirs.
5. Drivers/Riders are required to have a valid MSA Competition License and must be capable of the safe operation of the car or race car or motorbike or dragster at Tarlton.
6. The main purpose of the Armco barriers is to protect the paying public.
7. The only responsibility of Tarlton and Zumick is to provide the race track at Tarlton to participate in the car or race car or motorbike or dragster race or show which includes the necessary Emergency Services, i.e. Fire and Ambulance services also.
8. That it is my responsibility as Participant to ensure that all information contained on this Indemnity and Waiver Form is correct.
9. That I hereby declare myself to be fully acquainted with the nature and extent of the risk involved in participating in the car or race car or motorbike or dragster at Tarlton.
10. Prime responsibility for the safe condition and operation of a vehicle in competition rests with the vehicle owner and driver.
